The Latest Edition of the Bureau of Street Lighting's Blue Book titled "Special Specification for the Construction of Street Lighting Equipment" including current supplements, addenda and revisions is hereby incorporated in and made part of these Contract Documents. 2. **Replace** the General Requirements, Section 01212 "Fixed Cash Allowance Items" with attached revised **Section 01212 "Fixed Cash Allowance Items"** (1 sheet).
3. **Replace** the General Requirements, Section 01251 "Change Order Requests" including the attachments with the attached revised **Section 01251 "Change Order Requests"** (3 sheets).
4. **Replace** the General Requirements, Section 01254 "Change Orders" with the attached revised **Section 01254 "Change Orders"** (12 sheets).
5. **Replace** the General Requirements, Section 01562 "Environmental Mitigation" with attached revised **Section 01562 "Environmental Mitigation"** (5 sheets).
6. **Delete Attachment 01711-A1 "Summary of First Notice Replies"** dated March 16, 2006 from the General Requirements, Section 01711 "Site Investigation".
7. **Insert** the following paragraph at the end of the General Requirements, Section 01721 "Mobilization":

8. **Add** the attached **Technical Specifications, Section 2380 “Permanent Geosynthetic Turf Reinforcement Mat”** at the end of the General Requirements (7 sheets).

II. Geotechnical Investigations

**Add** the attached **Supplemental Geotechnical Report (GED File No. 05-030) entitled “Vermont Avenue Widening South of Pacific Coast Hwy - Supplemental Recommendations for New Storm Drain”** ( 58 sheets) to the end of the Geotechnical Investigations Booklet.

III. Project Plans

1. **Delete** Plan Sheet Nos. 3, 4 and 5 (Drawings R3, C1, and C2) from the project plans.
2. **Revise** the information contained on Plan Sheet No. 40 (Drawing L-12), “Legend” as follows:
  - a. **Add “2.5 Ton”** after “Specialty Boulder”.
  - b. **Add “0.3 Ton”** after “3.3 C.F. Boulder”.
  - c. **Add “Rip-Rap”** after “4” – 8” Sierra River Cobble” for both grouted and loose categories.
  - d. **Add “(Turf Reinforced Mat (TRM) or equals)”** after “Green Armor”.
  - e. **Change** Quantity/Size of 4” – 8” Sierra River Cobble (Grouted) from 170 S.F. to **230 S.F.**
  - f. **Change** Quantity/Size of 4” – 8” Sierra River Cobble (loose) from 1500 S.F. to **1380 S.F.**
  - g. **Change** Quantity/Size of Hydroseed Native California Species from 4400 S.F. to **3620 S.F.**
